PRIMARY SCHOOL PRIVACY NOTICE

Please read this notice before completing the enrolment form.

This confidential enrolment form asks for personal information about your child as well as family members and others that provide care for your child. The main purpose for collecting this information is so that the school can register your child and allocate staff and resources to provide for their educational and support needs. All staff at Patterson Lakes Primary School and the Department of Education & Training are required by law to protect the information provided by this enrolment form.

Patterson Lakes Primary School depends on you to provide all relevant health information because withholding some health information may put your child's health at risk.

Patterson Lakes Primary School requires information about all parents, guardians or carers so that we can take account of family arrangements. Family Court Orders setting out any access restrictions and parenting plans should be made available to the school. Please tell us as soon as possible about any changes to these arrangements. Please do not hesitate to contact the Principal, Carole Mayes, if you would like to discuss, in strict confidence, any matters relating to family arrangements.

Emergency Contacts

These are people that Patterson Lakes Primary School may need to contact in an emergency. Please ensure that the people named are aware that they have been nominated as emergency contacts and agree to their details being provided to Patterson Lakes Primary School.

Student Background Information
